Considering the practical difficulties being faced by Companies in conducting AGM on or before the due date of September 30, 2020 on account of the Covid-19 pandemic and after taking cognizance of the gravity of the public health situation; MCA, with a view to provide necessary relief to such companies, vide its Order dated September 8, 2020, extended the time within which Companies are mandated to hold the AGM by a period not exceeding three months i.e. till December 31, 2020.
2. A member entitled to attend and vote at the AGM meeting is entitled to appoint a proxy to attend and vote in the meeting instead of himself/herself and the proxy need not be a member of the Company. Proxies, in order to be effective must be received at the Company's Registered Office at Suite No-68A, 2nd Floor, 209, A.J.C.Bose Road, Kolkata-700 017, not less than 48 hours before the commencement of the Annual General Meeting.
A person can act as a Proxy on behalf of members not exceeding 50 members and holding in the aggregate not more than 10% of the Total Share Capital of the Company.
3. Corporate members intending to send their authorised representatives to attend the meeting are requested to send to the Company the certified copy of Board Resolution authorizing their representatives to attend and vote on their behalf at the Annual General Meeting.
4. Brief resume of Director including those purpose to be appointed/re-appointed, nature of their expertise in specific functional area, names of Companies in which they hold directorship and membership/Chairmanship of Board Committees, shareholding and relationship in between Directors inter-se as stipulated Pursuant to Regulation 36 of the SEBI (Listing obligation and disclosures Requirement) Regulation, 2015.

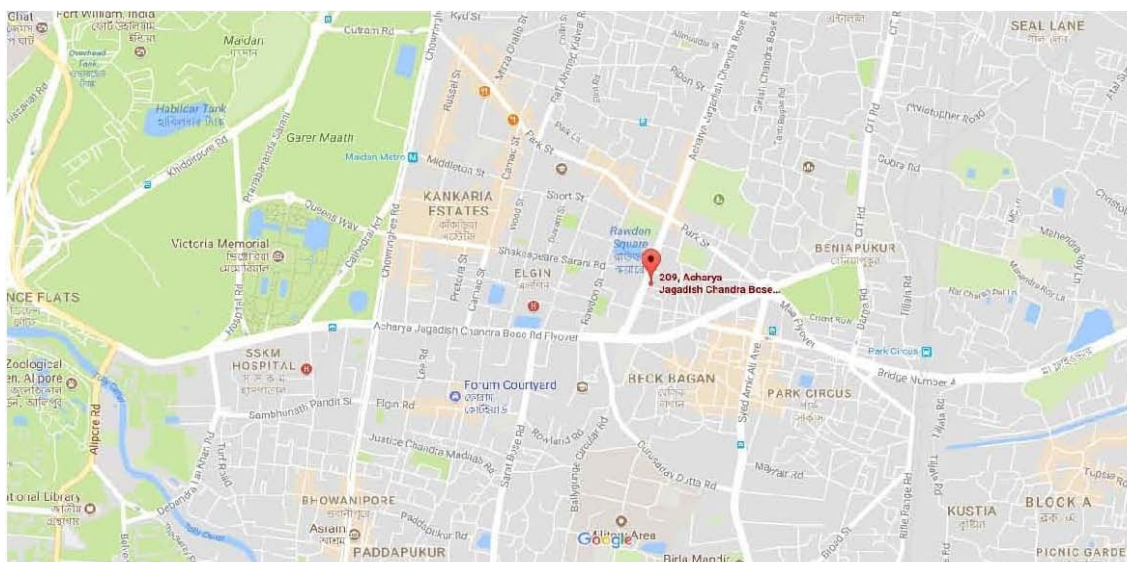
